The main purpose of Serbian SBR is to be a main frame for all business surveys. SBR collects Business
population data and store them into variables of standardized Statistical units. SBR Statistical units are updated
on a monthly basis from administrative sources and daily from statistical sources as well. Data collected through conducting various statistical surveys are used as SBR feedback. They have been followed regularly,
by Business survey managers. The intention is to include new administrative sources in order to decrease
response burden on reporting units.

Statistical Business register survey was conducted, including, for the first time, full scope of significant Enterprises 4. Data sources

#### Description of work (max 4-5 sentences)

Statistical Business register survey has been performed in November 2017th. The frame consisted from almost 8000 Businesses (units with more than 20 employees). Data are collected by web questioner, entered by responsible persons from Enterprises themselves. For the Enterprises with the extensive number of local units, different IT formats disposed for data output (excel, xml, etc.). The response rate was very high – over 98%.

Defining and bringing into force procedure for creating Business survey frames and updating SBR with the data collected performing various statistical sources

9. Planning and governance

#### Description of work (max 4-5 sentences)

Regarding the necessity of defining and monitoring all phases of data flow, from surveyed Statistical units into SBR database, a procedure that standardize the entire process of SBR updating had been adopted and become mandatory. The adopted procedure covers all communication between survey managers, data collection teams and SBR team. It also defines all phases of SBR updating with data from Statistical sources, starting with defining frame from SBR database, finishing with storing collected data into SBR database. All Statistical units that are parts of the frames are attached with a unique (SBR originated) ID numbers, which facilitate the way of its updating in SBR database

Quarterly publication issued by SBR has been redesigned

7. Dissemination

The redesigned SBR publication incorporates an overview of Legal units, with a point on its demography. Now, Legal units are presented in a clearer manner, convenient for analysis. They are aggregated at Municipality level, grouped by its registration status. It is also shown the number of new-born and ceased Legal units on a Municipality level, in presenting quartile.
