Until reference year 2017, status of being active was defined according to the tax types which were assigned for the businesses at their registration. In 2016, a protocol was signed between Revenue Administration and TurkStat which authorizes TurkStat to access financial tables and another protocol was signed between Social Security Institution and TurkStat which authorizes TurkStat to access employment data. From 2017 onwards, the criteria for being included in population of active enterprises for a reference period, actual turnover from Revenue Administration and employment from Social Security Institution is planned to be used.

Annual survey of EGs for the reference year 2016 was completed and previous year's EGs information was updated. The integration of EGs annual survey results to the BR System was actualized. Profiling studies have been finalized for the selected 3 units in Turkish BR under the IPAMBP 2014 Project. The results of the profiling study were compared with EGs results and necessary amendments for the inconsistent parts (number of legal units, control and share information,etc.) were done in the EGs field data.

Turkstat BR Group sent the BD birth, death, and survival series to Eurostat for the reference years 2012-2015 in compliance with validation and confidentiality rules. Data is now published at Eurostat's web page.
